Joan opened the meeting at 7:02pm.

Beck spoke about Warner Power not allowing us to come back down there this year. They have made it more impossible for Scott Miller to set up his rides in a safe amount of time so we are exploring other options at the school...

Scott Miller spoke about the "sensitive" ball fields and athletic fields that he has put his rides on at other events. He talked about how he can hold funds aside for any fixes/damages that may occur to cover.

Jerry Frew spoke about the sprinkler system that was put in and that they would most likely be concerned about how the rides were going to effect that. – Scott made the comment that he would be willing to fix anything that he were to potentially damage.

Scott will do some more layout charts and get back to us on several options for us to present to the facilities board to gain their approval.

Jerry spoke about eh application process of presenting to the Facilities Board and to get that in sooner rather than later so they have time to review it before the May meeting. In the application it goes over how if there were any damages that the school would get their own people to fix it and then submit the bill to the Festival to reimburse them.

Warner Power: Talked about possibly going back there to see if there was way they could park all in one parking lot for the day or even over at Riverside Park so that Scott Miller had more time to set up rides for this year (pending the findings for the school layout being approved).

Jerry stated that the school itself could be used by us as well. Mentioned about hosting a dinner and some other activities that could be held in the cafeteria area. Also reminded us of the Kindergarten playground on the other side of the school that could be used as well.

Jerry will send Chandra the names of the people on the facilities board.
