



FARM AND FIELD APPLICATION – 2017

Festival Dates: **October 7th (9:00am to 6:00pm) and 8th (9:00am – 4:00pm)**

The Warner Fall Foliage Festival is an annual free-admission family oriented community festival that attracts thousands of attendees over Columbus Day weekend since 1947.

Spaces & Fees:

1. Spaces are 12' x 12' and are on a tarred surface.
2. Vendors must provide their own tents, tables, chairs,
3. A 10'x10' tent space is \$150.00.
4. An additional \$1.50 will be added per additional sq. ft. needed. *

* The WFFF Board of Directors will review vendor requirements for additional space, and assign a location based on space available.

Application Procedures:

1. Completed application must be received no later than September 12, 2017.
2. Mail signed application along with a copy of your **Certificate of Liability** listing the Warner Fall Foliage Festival as a recipient to: WFFF Farm and Field Coordinator, PO Box 152, Warner, NH 03278.
3. Application does not guarantee selection.
4. If all vendor spots have been filled, we will accept backup applications. You will be notified if you are on the wait list.
5. If and when accepted, please make your check or money order payable to "WFFF" and mail it to the same address listed above. Any returned checks will be subject to a \$35.00 returned check fee.

Farm and Field Rules:

1. Vehicle access to vendor spots must be before 8:00am or after 9:00pm on Saturday, and/or before 8:00am or after 6:00pm on Sunday.
2. Vendor agrees to remain open until 6:00pm on Sunday.
3. Vendor space must be cleaned and swept before you leave.
4. No alcohol or political material may be displayed or stored on WFFF grounds.
5. Make sure your tents are weighted and secured in the event of inclement weather.
6. In the event a vendor must cancel a space reservation, the Festival board must receive a written cancellation request by September 15th. Refund of the space will be offered up to October 1st. No refunds are offered after that date for *any* reason including weather, extenuating circumstances, ejection from the festival for rule violations, etc.
