



FOOD VENDOR APPLICATION - 2019

Festival Dates: Friday, October 11th (6pm to 9pm), Saturday, October 12th (9am-6pm), and Sunday, October 13th (9am – 5pm) The Warner Fall Foliage Festival is an annual free-admission family-oriented community festival that has attracted thousands of attendees over Columbus Day weekend since 1947.

Spaces & Fees:

1. Minimum spaces are 12' x 12' and are on grass with a few on concrete, or a combination of the two.
2. Vendors must provide their own tents, tables, chairs.
3. A 12'x12' tent/trailer space is \$3.50/sq. ft. equaling \$504*
**(Any vendors requiring larger spaces will be reviewed individually by the WFFF Board of Directors and allocation will be dependent on available space.)*
4. An additional \$25.00 will be added per utility needed (Electricity and Water)

Food Vendor Application Procedures:

1. Completed application must be received no later than August 30, 2019.
2. Mail signed application along with a copy of your Certificate of Liability listing the Warner Fall Foliage Festival as a recipient to: **WFFF Food Vendor, PO Box 152, Warner, NH 03278.**
3. Application does not guarantee selection. Initial acceptance and rejection will be emailed by September 5, 2019.
4. If all vendor spots have been filled, we will accept back up applications. You will be notified if you are wait listed.
5. If and when accepted, please make your check or money order payable to "WFFF" and mail it to the same address listed above. Any returned checks will be subject to a \$35.00 returned check fee.

Food Vendor Rules:

1. Vehicle access to vendor spot must be before 6:00pm or after 9:00pm on Friday, before 8:00am or after 9:00pm on Saturday, and/or before 8:00am or after 6:00pm on Sunday.
2. Vendor agrees to remain open until 5:00pm on Sunday.
3. Vendor space must be clean and raked by 10:00pm Sunday, Oct. 13, 2019.
4. No alcohol or political material may be displayed or stored on WFFF grounds.
5. Make sure your tents are weighted in the event of inclement weather. When accepted, if you are unsure if your space is on concrete or grass, you may contact the vendor coordinator so you can plan accordingly.
6. In the event a vendor must cancel their space, we must receive a written cancellation request by September 15th. Refund of the space will be offered up to September 15th. No refunds are offered after that date for any reason **including weather, extenuating circumstances, ejection from the festival for rule violations, etc.**
